Speaker 1: Yeah, cap. Sailing Vessel Ventura here at the World Trade Center. There's been a major explosion at the top of the World Trade Center. Thought you might need to know.

Speaker 2: Ventura, Coast Guard Activities New York, roger.

Speaker 1: Looks like a plane hit it.

Operator: Ventura Coast Guard Activities New York interested in the information. We'll make sure everyone's notified. Over.

Speaker 1: Roger. Ventura out. What's going on at the World Trade Center?

Speaker 4: They report a 737 has hit about the 100th floor up the South Tower.

Speaker 5: [inaudible 00:01:51].

Speaker 2: Roger, go ahead [inaudible 00:01:55].

Speaker 5: 68.

Speaker 2: [00:01:30] They say no way it's a [00:02:00] jet that size. They're thinking it's a light airplane.

Speaker 6: [inaudible 00:02:05] 68.

Speaker 1: Group New York [00:02:30] Sailing Vessel Ventura.

Operator: Let's go ahead. Coast Guard activities on the way.

Speaker 7: Ventura activity New York Guard.

Speaker 1: Yeah, Cap. I'm in North Cove World Financial Center. We're pulling a couple of boats out of here. If you need to come in to do whatever you need, the

northeast corner of the marina is open for boats if you need them.

Speaker 7: Ventura activities in New York, roger. [inaudible 00:02:58] York activities [inaudible 00:03:00].

Speaker 8: [inaudible 00:03:04]. [00:03:00] Fire fighter.

Speaker 9: [inaudible 00:03:21] barge at Bayonne Bridge. This is New York Traffic [inaudible 00:03:25] call me landline at [inaudible 00:03:28]. I say again, [00:03:30] Mr. [Reese 00:03:32] the blasting barge, Bayonne Bridge, call BTS landline. BTS New York out.

Speaker 10: [inaudible 00:03:42] standby for Reynolds [inaudible 00:03:44].

Speaker 2: [inaudible 00:03:51] this is... [inaudible 00:03:51] Chesapeake, [inaudible 00:03:51] Chesapeake, three two. [inaudible 00:03:51] United States Coast Guard Activities New York, United States Coast Guard Activities New York. Coast Guard Captain of the Port has established a safety zone 1000 yards radius of the Statue of Liberty. No vessels allowed to move within the zone without authorization from the Coast Guard Captain of the Port New York. Break. This is United States Coast Guard Activities New York out.

Operator: [inaudible 00:04:39] 8325 Coast Guard Activities New York, over.

Speaker 12: If we need assistance at the Statue of Liberty here and [inaudible 00:04:53] 8290 is on its way now also.

Operator: I think [inaudible 00:05:03]. Can you say again [00:05:00] the number of the vessel [inaudible 00:05:06]?

Speaker 12: My unit's 8325 and the other vessel on its way here is 8290.

Operator: [inaudible 00:05:20] Activities, roger. [inaudible 00:05:23] and we'll let you know, over.

Speaker 12: I will be awaiting your instructions.

Speaker 13: U.S. Coast Guard [00:05:30] Activities Group New York this is the sailing vessel Half Moon, channel 16.

Operator: Sailing vessel Half Moon this is Coast Guard Activities New York, over.

Speaker 13: Can we switch to channel 22 alpha, [00:06:00] please?

Operator: Roger. Switching 22.

Speaker 14: [inaudible 00:06:02] please.

Speaker 15: Vessel disabled by the [inaudible 00:06:04] Bay Bridge. [inaudible 00:06:05].

Speaker 9: [inaudible 00:06:07]. You can finally got to come [inaudible 00:06:07] Bay Bridge and you finally... This is the Proline, please, over.

Speaker 16: Roger, Proline. Go to 78, please. 78 on your radio. You have 78? 78.

Speaker 2: Security, security, security. This is the [00:07:30] United State Coast Guard Activities New York, United States Coast Guard Activities New York. [inaudible 00:06:51] safety broadcast is initiated. The Captain of the Port New York has suspended all vessel traffic in the Upper New York Harbor [00:08:00] until further notice. No vessels may operate in New York Harbor north of 40 [inaudible 00:07:04] 40 north, south of the George Washington Bridge or south of the Tri-Borough Bridge, including the waters of the Harlem River without specific permission from the Captain of Port New York. Break. This is United States Coast Guard Activities New York out. [inaudible 00:08:20].

Security, security, security. All stations, this is United States Coast Guard Activities New York, United States Coast Guard Activities New York safety broadcast is initiated. Speaker 18: Newark 25, checking in okay also.

Speaker 19: [00:09:00] It's Joey. Everybody else will work off 16 or you want to take another channel here? Stay on 16 where yours is.

Speaker 1: I'll stay on 16 until further advice, I guess.

Speaker 19: Yeah, [inaudible 00:09:05] dead too, right?

Speaker 1: Yeah. It's dead. Cell phones too.

Speaker 19: All right.

Speaker 20: Port of New York, Port of New York. Sailing with the Valkyrie, [inaudible 00:09:10] whiskey 7892, channel 16.

Speaker 21: I'm coming towards the obstruction buoy. Heading towards the base in there, about one mile.

Speaker 20: Coast Guard New York, Coast Guard New York, sailing with the Valkyrie. Whiskey Charlie, Whiskey 7892, channel 16.

Speaker 18: Newark 25. [inaudible 00:09:35]. Newark 8325.

Speaker 22: [00:09:30] New York City [inaudible 00:09:47] [Avante 00:09:47]. New York City [inaudible 00:09:47] Avante.

Operator: [inaudible 00:09:47].

Speaker 18: Newark, 8325, channel 16.

Speaker 20: Coast Guard New York, sailing with the Valkyrie. 16.

Speaker 22: New York City Coast Guard Avante.

Speaker 2: Uniting calling with the Coast Guard Activities New York. Coast Guard-

Speaker 22: We're [00:11:00] at [inaudible 00:11:12] river. What's the situation at World Trade? Should we try to evacuate anybody off the sea wall? Over. [00:11:30] New York City Coast Guard Avante. Over.

Speaker 2: Unit calling. This is Coast Guard Activities New York request you say again. You're coming in all broken.

Speaker 22: Yes, sir, this is the private yacht Avante. We're just north of the situation on the World Trade Towers. Would you like us to try to evacuate anybody off the north sea wall? Over.

Speaker 23: Rockaway Bay.

Speaker 19: Go to 10.

Speaker 22: [00:12:00] New York City, Avante. Over.

Speaker 2: New York, that's a negative, sir.

Speaker 22: Yes, sir. Roger. Avante standing by.

Speaker 2: Coast Guard New York Valkyrie?

Speaker 23: Coast Guard, Coast Guard, I just saw another plane take a dive.

Operator: New York Coast Guard you are [inaudible 00:12:25]. They're reporting another plane. This is Coast Guard Activities New York, over.

Speaker 23: East side of the George Washington Bridge going into Fort Lee.

Speaker 18: North Bay 8325, channel 16.

Speaker 24: This is the [inaudible 00:12:27] town marina, [00:12:30] please switch and [00:13:00] answer to 09.

Speaker 25: [inaudible 00:13:24] Coast Guard station, 16. [inaudible 00:13:28].

Speaker 26: Coast Guard Station New York, this is NYPD [inaudible 00:13:29] rescue 14.

Operator: NYPD [inaudible 00:13:31] Coast Guard Activities New York, over.

Speaker 26: [00:13:30] Ma'am, I'm sure you're aware of the ongoing

situation at World Trade Center. At this time it's inevitable that the North Tower is going to collapse. If it does, it's going to be collapsing on marine traffic. We still have ferries operating between New Jersey and Battery Park. We need them to stop operating immediately.

Operator: NYPD [inaudible 00:13:50] of Activities New York, that's a roger. [inaudible 00:14:17]. [00:14:00] NYPD [inaudible 00:14:22] to ocean port.

Speaker 27: United States Coast Guard, United States Cost Guard.

Operator: [inaudible 00:14:39] this is Coast Guard Activities New York. Over.

Speaker 27: This is Neptune's Champion, [00:14:30] a private vessel in lower New York Harbor. We wonder if you need any volunteer assists with any rescue or emergency equipment over to New York City? [inaudible 00:14:53].

Operator: [inaudible 00:14:53] volunteering assistance, this [00:15:00] is Coast Guard Activities New York. Please be advised no assistance is needed at this time. Please keep in mind that security [inaudible 00:15:25] that we have, over.

Speaker 27: Okay. Roger. This is Neptune's Champion monitoring 16 on the side lower New York Harbor.

Speaker 20: [00:15:30] Coast Guard New York [inaudible 00:15:34] Valkyrie 16.

Operator: Thanks for calling. This is Coast Guard Activities New York, over.

Speaker 20: Roger. We're at 95 [inaudible 00:15:39] depart New York Harbor. We're [inaudible 00:15:39] for the Battery Park area.

Operator: Thank you again for calling. This is Activities, sir. [inaudible 00:15:39].

Speaker 20: This is [inaudible 00:15:39] we're [inaudible 00:15:39] marina. And we'd like to depart [inaudible 00:15:39] to depart, over. You have a-

Operator: NYPD Aviation, this is Activities, over.

Speaker 20: [inaudible 00:15:39] on shore. [inaudible 00:15:39].

Speaker 26: Coast Guard Station, NYPD SE14.

Operator: NYPD, this is Coast Guard Station New York on channel 16, over.

Speaker 26: Ma'am, do you have a [inaudible 00:17:00] at this time to the Battery Park area? Do you copy there for [00:16:30] NYPD 14?

Operator: NYPD [inaudible 00:16:52] 14, this is Activities New York Command Center, [00:17:00] over.

Speaker 26: Yes, ma'am. This is NYPD 14. Do you have any Coast Guard vessels en route at the start of the Battery Park city?

Operator: We do have three standing off the battery. [00:17:30] The Coast Guard kind of has a [inaudible 00:17:31] at this time.

Speaker 26: Okay, ma'am. Just confirming. Just want to let them know also that we have evacuations going on with private ferries. If this tower goes down it's probably going to hit the water.

Operator: Roger, you're kind of on the west side there?

Speaker 26: It's the North Tower on the west side and it's about 15 to 20 floors might possibly collapse and will hit the water if it collapses.

Operator: Roger. We're going to be going over commercial traffic to let the commercial vessels... If they can start moving [00:18:00] away from the battery at this time and just get into the upper harbor.

Speaker 26: Okay ma'am. Please also be advised at this time we have numerous helicopter and medevac helicopter aircraft mobilizing at the old [inaudible 00:18:11] Field Coast Guard station. There are many aircraft en route.

Operator: Roger. Our Atlantic City [inaudible 00:18:18] is on recall standby. DO you need assistance let us know. We'll send them because we have no health service at this time.

Speaker 26: Okay. Roger, ma'am, because if they [inaudible 00:18:25] in it's going to be massive, massive casualties and massive medevac.

Operator: Coast Guard Activities New York, Army Corps [inaudible 00:18:27] on channel 16. Army Corps of Development this is Coast Guard Activities New York 16.

Speaker 29: Roger, Coast Guard, this is [inaudible 00:18:28]. We're

[00:18:30] standing by here at Cable Point Marine Terminal [inaudible 00:19:02] [00:19:00] harbor. Did you guys request additional units to help evacuate people from the [00:19:30] sea wall?

Speaker 26: NYPD Aviation, Coast Guard Activities New York 16.

Speaker 30: 37 [inaudible 00:19:35] loading this boat up pretty good.

Speaker 31: Aurora, copy. Give me a description of your vessel and how many people you have on board.

Speaker 32: How you doing Eric?

Speaker 33: [00:20:00] This is [inaudible 00:20:02] if anybody can copy me, please respond.

Speaker 31: Aurora, can you repeat your [inaudible 00:20:16] on board? You said 404 passengers and 804 crew? What's your total [inaudible 00:20:28] on board, including passengers?

Speaker 33: Operator, over, on 16. Operator over, on 16.

Speaker 31: Roger, what-

Speaker 33: Operator, over, on 16.

Speaker 31: ... position [00:20:30] right now. We don't have vessels this close in.

Speaker 33: Operator, over, on 16.

Speaker 34: Slow the ferry down a little bit. We're gassing up one of the federal boats. Slow the ferry down [inaudible 00:20:49].

Speaker 35: [00:21:00] Coast Guard, [inaudible 00:21:10] to the RP Corps boat, channel 16.

Operator: Corps boat, this is station on channel 16, over.

Speaker 35: Roger, station, [inaudible 00:21:13] and wonder whether we could appoint to the battery where the Army Corps survey vessel [00:21:30] could use our assistance?

Speaker 36: Chelsea [inaudible 00:21:34], Chelsea [inaudible



00:21:35], Paragon.

Speaker 37: Might be radio watch 1033, out.

Speaker 36: Chelsea [inaudible 00:21:44], Chelsea [inaudible 00:21:48], Paragon.

Speaker 38: Coast Guard Activities Com Center, Coast Guard Activities Com Center, this is February 20, channel 16, over.

Speaker 39: Coast Guard [inaudible 00:22:07] Atlantic City Coast Guard [inaudible 00:22:08] Atlantic City, Coast Guard [00:22:00] Activities New York, channel 16. [inaudible 00:22:20].

Speaker 38: Activities New York, detail 16.

Speaker 39: I have active phone service here in Jersey, would you like me to contact through Atlantic City for you?

Speaker 38: [inaudible 00:22:27] Activities, that's a negative.

Speaker 39: Activities New York, Activities New York, Group Atlantic City on channel 16.

Speaker 38: [inaudible 00:22:27] Atlantic City, this is [00:22:30] Coast Guard Activities New York, roger. We are requesting a Coast Guard [inaudible 00:22:52] en route to Floyd Bennett Field, over.

Speaker 39: Activities New York has [inaudible 00:22:58].

Speaker 38: Activities New York [00:23:00] copy. All your phone lines are down. You're collecting one [inaudible 00:23:05] Floyd Bennett Field. [inaudible 00:23:08] specialized equipment [inaudible 00:23:12] personnel, over.

Speaker 39: This is Atlantic City, Activities New York, be advised they're primarily going to be used as medevacs for however many days at this point, over. Activities New York, Atlantic City, roger. Medevac purposes. [inaudible 00:23:26] Floyd Bennett Field. We'll have that [inaudible 00:23:38] [00:23:30] on line fast and they'll be up there momentarily. We'll advise the [inaudible 00:23:52] Airborne. We'll standby on channel 16. Out.

Speaker 38: [inaudible 00:23:53] Atlantic City, Activities New York, as many as you can support. We'll probably need more than one.

Speaker 39: Roger, [00:24:00] New York, as many as we can spare.

I'll get the operations office. We'll see how many we can send to you. As soon as we find out we'll advise.

Speaker 38: [inaudible 00:24:07] Atlantic City. Activities New York, roger. And also be advised that they can land here in Fort Wadsworth if they [00:24:30] have no other airspace to land in.

Speaker 39: Roger, we can land in Fort Wadsworth. Are their fuel capabilities there at Fort Wadsworth?

Speaker 38: That's a negative.

Speaker 39: Roger, we'll probably plan ongoing to Fort Bennett for fuel and I'll also advise, if they ask, that they can land at Fort Wadsworth. We'll be standing by on 16. Anything further?

Speaker 38: Roger, be advised the request for now is to fly directly to Floyd Bennett and that's from the NYPD.

Speaker 40: [Bethel Sea Street 00:25:00], [00:25:00] Bethel Sea Street, this [inaudible 00:25:03] standing by channel 16, over.

Speaker 39: Roger, Coast Guard said fly to Floyd Bennett first and contact NYPD. They have gone there to coordinate.

Speaker 38: Roger, just have the work with NYPD.

Speaker 39: Roger, NYPD will have somebody waiting. So expect them up there within an hour.

Speaker 38: Atlantic City, Activities New York, roger. Thank you for your assistance.

Speaker 40: [00:25:30] Bethel Sea Street, Bethel Sea Street, this [inaudible 00:25:54] channel 16, over. Bethel Sea Street, Bethel Sea Street [inaudible 00:25:57] channel 16, [00:26:00] over. [inaudible 00:26:09].

Operator: [inaudible 00:26:09] New York Activities.

Speaker 40: We got a vessel, Geraldine, right up here with an engine bursting for the bomb [inaudible 00:26:18]. Vessel Geraldine.

Operator: Roger. I understand it's vessel Geraldine. Are they standing my the channel, over?

Speaker 41: I'm here ashore and the police are trying to get someone to lift them out. I'm right north of Pier [inaudible 00:26:28]. Over.

Operator: Roger, is this [00:26:30] vessel Geraldine speaking?

Speaker 41: Come back?

Operator: This is the Coast Guard, is this vessel Geraldine, over?

Speaker 41: [inaudible 00:26:46] over.

Operator: Roger. What are the injuries a this time, over?

Speaker 41: They said it's neck and back. [inaudible 00:26:48] medics and NYPD here, over.

Operator: Roger, is the person stable?

Speaker 41: The person's stable but the medic [inaudible 00:27:01].

Operator: [00:27:00] Roger, we want to confirm that there are medics and NYPD [00:27:30] on scene at this time, is that correct?

Speaker 41: [inaudible 00:27:31].

Operator: [inaudible 00:27:31] call an emergency [inaudible 00:27:31]. Roger, are they requesting to be airlifted at this time, over? Geraldine, this is the Coast Guard, what is your exact position?

Speaker 42: Motor vessel [Holly L 00:27:48] calling Coast Guard Activities New York.

Speaker 38: Unit calling, this is Coast Guard Activities New York.

Speaker 42: Yeah, good morning. This is motor vessel Holly L, is the [00:28:00] harbor open at this time? I have men working on the Brooklyn piers I'd like to go pick up.

Speaker 38: Holly L, Activities New York, the harbor is not open. It is closed to all traffic.

Speaker 43: Aruba, Aruba [inaudible 00:28:13]. Aruba-

Speaker 44: Fire fight off of [inaudible 00:28:13].

Speaker 43: Aruba, Aruba, this is [inaudible 00:28:13].

Speaker 45: [inaudible 00:28:13] marine, port mobile [inaudible 00:28:13] marine, over. Port mobile marine, port mobile marine, S marines.

Speaker 46: Coast Guard station from the pleasure boat Reel In.

Speaker 45: Port mobile marine, port mobile marine. S marines.

Speaker 43: Aruba, Aruba, this is [inaudible 00:29:19].

Speaker 46: Pleasure boat Reel In.

Speaker 47: Dial in Coast Guard, this is Coast Guard Station Sandy Hook, channel 16, over.

Speaker 43: Aruba, Aruba, this is [inaudible 00:29:33].

Speaker 46: We heard they're going to close down my marina, the Atlantic Highlands. Is that true?

Speaker 47: Dial in Coast Guard, this is Coast Guard station Sandy Hook, channel 22 alpha.

Speaker 48: 22 alpha.

Speaker 49: [inaudible 00:29:52] harbor [inaudible 00:29:54] one here in Brooklyn. [inaudible 00:29:57] assistance [00:28:30] over on the [inaudible 00:29:59] there.

Speaker 47: Dial in Coast Guard, this is Coast Guard station Sandy Hook channel 16, over. [inaudible 00:30:18]. Dial in Coast Guard, this is Coast Guard station Sandy Hook, channel 16, over.

Speaker 50: Activities New York, Activities New York, [inaudible 00:30:43] Lawrence Billy.

Operator: Lawrence, this is Activities New York, over.

Speaker 50: Activities New York, [inaudible 00:30:49].

Operator: [inaudible 00:30:52] activities, switch channel 22.

Speaker 50: Channel 16, I don't know if anybody wants to [00:31:00] know, but there's a small aircraft off the tip of the hook flying about 100 feet off the water. It's headed down towards the city right now. [inaudible 00:31:09].

Speaker 51: Coast Guard Activities [00:31:30] New York, Activities New York, I'm about to do a small [inaudible 00:31:45]. Coast Guard Activities New York, do you [inaudible 00:31:51]. A bunch of ferries saving gas [inaudible 00:31:51] we have a [inaudible 00:31:51] station and EMTs standing by, so if there's no [00:32:00] place else where we can bring them or if they're having a hard time [inaudible 00:32:22] you can bring them to Ellis.

Speaker 52: Coast Guard Activities New York, U.S. Customs. Coast Guard Activities New York, U.S. Customs.

Speaker 38: U.S. Customs, Activities New York.

Speaker 52: Coast Guard Activities New York, can you please advise the status of the harbor? Is it closed at this time?

Speaker 38: U.S. Customs, Activities New York, roger. [00:32:30] Be advised, we have closed the harbor to all traffic. All commercial and private traffic.

Speaker 52: Copy that. You have any idea if it will be closed going into tomorrow, copy?

Speaker 38: Customs, Activities New York, we don't have a definite answer on that, but as of right now it might be looking that way.

Speaker 52: Copy that, sir. Thank you.  
(silence).

Speaker 53: We got a plane [00:33:30] out here either in trouble or something's up. He's at the tip of the hook and the Sandy Hook Bridge. He's flying around in a circle. He's sideways. Something's up.

Operator: [inaudible 00:33:48] reporting a plane, this is Coast Guard Activities New York on 16.

Speaker 53: This guy's in trouble.

Operator: Roger, sir. Can you [inaudible 00:33:56] your last transmission.

Speaker 53: A little small plane is now [00:34:00] turned and he's

going north up the beach. He's got real bad control of the plane and he's been circling around here for the last 20 minutes.

Operator: Roger, can I have the name of your vessel?

Speaker 53: Bob's [inaudible 00:34:16].

Operator: What was that, over?

Speaker 53: Bob's [inaudible 00:34:19].

Operator: Bob's [inaudible 00:34:19], Activities, stand by.

Speaker 53: 10-4. He's right up above the [inaudible 00:34:20] beach, right now and heading towards the north. [inaudible 00:34:20] 16, picking up.

Speaker 54: [inaudible 00:34:20] Zodiac, where does the hill top go?

Speaker 55: That's correct. [inaudible 00:34:23] 13.

Doug Berg: [inaudible 00:34:23] I'm calling Activities New York.

Speaker 53: South Cove Marina.

Speaker 54: Purple Hornet, Purple Hornet, Wasp, 16, pick it up.

Doug Berg: [inaudible 00:35:24] Activities New York. This is [Doug Berg 00:35:35] I'm calling Coast Guard group.

Speaker 38: Doug Berg [inaudible 00:35:35], Activities, go.

Doug Berg: Yes, do you need any [00:35:30] help evacuating nay people from Manhattan? We're right off Governors Island.

Speaker 38: Doug Berg [inaudible 00:35:57], Activities, stand by.  
Where are you located?

Doug Berg: We're [00:36:00] right off Governors Island. We're a tug boat.

Speaker 57: Activities New York, Lincoln Harbor Yacht Club,  
Weehawken.

Speaker 38: Lincoln Harbor Yacht Club in Weehawken, Activities.

Speaker 57: Roger that, we have an open pool. If you need space to land boats, emergency craft, if you want to evacuate people, we'll be glad to help. We're on 74.

Speaker 38: Lincoln Harbor Yacht Club, Activities, roger. Standby.

Speaker 57: Roger that, 74 and 16.

Speaker 58: 27 foot pleasure yacht out of Jersey City. We're about 300 yards off Manhattan. You need a hand? 27 foot pleasure yacht about 300 yards from Manhattan. You guys need a hand? [inaudible 00:37:02].

Speaker 38: 16.

Speaker 59: Boat ahoy, boat ahoy. 16, pick it up. [inaudible 00:37:19] please.
